Conditions Of Play:

- Official Ball : Pro Penn HD in all divisions.
- Must be a current USAR member or join at the event.
- All USAR rules apply for amateur divisions.
- Amateur matches and consolation finals will be best of 2 games to 15, tie breaker to 11. Amateur consolation matches will be 1 game to 21. Pro matches will be best of 5 games to 11 and must be won by 2 points.
- You may enter up to 2 events.
- One serve rule for open divisions.
- You must check in and be ready 30 minutes prior to the scheduled match time.
- No refunds granted after entry deadline of October 22, 2011.
- Losers will referee following their match. Player has a choice to referee and get their referee fee refunded or it will be paid to an alternate referee.
- Approved eye guards for racquetball are required.
- We reserve the right to reclassify players or combine events with less than 5 entries.

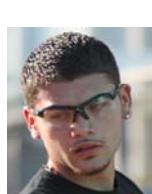
